A Regular Member must have an established commercial location where business is regularly transacted, maintain glass industry equipment, products, or supplies, and maintain proper books of accounts and records.
<input type="checkbox"/>	Branch Member: Any Regular Member belonging to the OGA and operating at more than one location under the same ownership may join as a Branch Member for any or each of the locations provided that a full Regular Membership is first held by the company. Branch Members have no voting rights in the affairs of the OGA.

ANNUAL DUES (Payment must accompany application)

All membership dues are paid annually (July 1 through June 30) and are based upon a company's gross annual sales in the glass industry. A company admitted to membership between July 1 and December 31 pays full dues for its first year. A company admitted between January 1 and June 30 pays ½ dues for its first year. Payments to the OGA are not tax deductible as charitable contributions for federal income tax purposes. However, they may be tax deductible under other provisions of the Internal Revenue Code.
